Camps: Award-winning, year-round outdoor day camps with areas of focus that include nature exploration and naturalist skills, games, problem-solving, and mentoring kind, curious, and confident kids. 133 camp seats were filled between January 1 and March 13, 2020.

Field Studies: Curriculum-aligned, hands-on, outdoor field trips that inspire students' curiosity and excitement to learn more about science, social studies, and cultural history. 306 elementary and middle school students were served between January 1 and March 13, 2020.

Leadership Development: Opportunities for 13-17 year olds to discover their own leadership style and practice necessary leadership skills in our award-winning outdoor day camps. Skill building occurs through the creation of individualized goals, personal development plans, real time feedback, and a weekly coaching session with senior staff to assess individual progress. During 2020, we had 3 in-person leadership training participants prior to the March 13th COVID cancellation; 29 additional participants took part in our online leadership training session in June 2020.
